About the situation

On 16 November 2017, human rights defenders Pham Doan Trang, Bui Thi Minh Hang and Nguyen Quang A were arrested by police after attending a meeting with the European Union Delegation in Hanoi to discuss human rights issues ahead of the EU - Vietnam Human Rights Dialogue, scheduled for 1 December 2017. After being kept incommunicado without access to legal representation, the human rights defenders were released. They remain under surveillance.

In 2012, after being arrested and interrogated, she published a recording of her interrogation and was reportedly forced to temporarily leave the country. She returned to Vietnam in January 2015.

Three human rights defenders arrested after meeting the EU Delegation in Hanoi

On 16 November 2017, human rights defenders Pham Doan Trang, Bui Thi Minh Hang and Nguyen Quang A were arrested by police after attending a meeting with the European Union Delegation in Hanoi to discuss human rights issues ahead of the EU - Vietnam Human Rights Dialogue, scheduled for 1 December 2017. After being kept incommunicado without access to legal representation, the human rights defenders were released. They remain under surveillance.

[Bui Thi Minh Hang \(/en/profile/bui-thi-minh-hang\)](/en/profile/bui-thi-minh-hang) is a human rights defender, blogger, and documenter of human rights violations in Vietnam. She also advocates for freedom of religion and has provided support to victims of land grabs. In 2011, Bui Thi Minh Hang was arrested and sent to a “re-education camp” for six months as a result of her activism. In June 2012 the human rights defender was released, however she was arrested again in February 2014 while visiting a former prisoner of conscience. In August 2014, she was sentenced to three years in prison for “causing public disorder”. She was released in February 2017.

[Nguyen Quang A \(/en/profile/nguyen-quang\)](/en/profile/nguyen-quang) is a human rights defender and a prominent member of Vietnamese civil society. In 2007, he co-founded the Institute of Development Studies (IDS), an independent, non-profit think-tank, since closed, that frequently questioned the government’s policies. In 2013, he co-founded the Civil Society Forum in response to Decree 72, a party document that limits online expression. The forum has, among other activities, organised protests against environmental damage and promoted the participation of independent candidates for Parliament elections. Lately, Nguyen Quang A has been extremely vocal regarding the [2016 Formosa spill \(https://www.reuters.com/article/us-vietnam-environment-formosa-plastics/vietnamese-protest-one-year-after-formosa-spill-disaster-idUSKBN1782GJ\)](https://www.reuters.com/article/us-vietnam-environment-formosa-plastics/vietnamese-protest-one-year-after-formosa-spill-disaster-idUSKBN1782GJ), an industrial disaster which caused tens of thousands of fishermen to lose their source of livelihood.

On 16 November 2017, human rights defenders Pham Doan Trang, Bui Thi Minh Hang, Nguyen Quang A and Chi Tuyen met with the EU Delegation in Hanoi ahead of the EU-Vietnam Human Rights Dialogue. They discussed the current human rights situation in Vietnam, including the Formosa spill, along with freedom of religion in the country. Following a two hour meeting, at around 11:30 am, the four human rights defenders exited the EU building. Bui Thi Minh Hang and Pham Doan Trang left together, while Nguyen Quang A and Chi Tuyen left separately in a different direction. Shortly after leaving, Bui Thi Minh Hang and Pham Doan Trang were arrested together by roughly 10 policemen and were brought to separate police stations. Pham Doan Trang’s phone was confiscated along with her laptop. Nguyen Quang A was arrested separately on his way home. Around midnight, police escorted Pham Doan Trang back to her home in Hanoi, however she has not been able to make contact with anyone as neither her phone, nor her laptop were returned to her. Nguyen Quang A and Bui Thi Minh Hang were both released after a few hours. All three human rights defenders were interrogated during their detention.

Authorities in Vietnam have a habit of tightening the grip over human rights defenders and civil society ahead of international meetings. During the APEC Summit in Danang between 6 and 10 November 2017, and afterwards, during the state visits of U.S. President Donald Trump and Chinese President Xi Jinping, several human rights defenders and activists were kept under house arrest and heavy surveillance. Reports also state that human rights defenders were harassed by policemen in plainclothes to prevent them from meeting with international officials or organising demonstrations.

Front Line Defenders strongly condemns the arbitrary arrests of human rights defenders Pham Doan Trang, Bui Thi Minh Hang and Nguyen Quang A which is a violation of the

Front Line Defenders urges the authorities in Vietnam to:

1. Immediately cease all forms of surveillance and harassment of Pham Doan Trang, Bui Thi Minh Hang and Nguyen Quang A, as it is believed that these measures are not only solely related to their legitimate human rights activities but, furthermore, constitute a direct transgression of their rights;
2. Immediately return the phone and laptop confiscated from Pham Doan Trang during her detention as they are manifestly unrelated to any criminal activity;
3. Cease targeting all human rights defenders in Vietnam and guarantee in all circumstances that they are able to carry out their legitimate human rights activities without fear of reprisals and free of all restrictions including judicial harassment.
